

Regional Consultative Meetings

- Consultative multi-stakeholder environmental dialogues organized regionally by the UNEP MGS
- Focus on regional priorities, challenges, observations, solutions...
- Also capacity-building and networking platform for MGS in the region
- Lookback or preparations for UNEA (but also others like UNFCCC COP)
- Usually held annually back-to-back with Environmental For a (the AMCEN in Africa)
- Main outcome:
 - Statements and recommendations by MGS for consideration by regional fora and UNEA
 - Expert contribution to decision-making (specific to AMCEN)

- Review of AMCEN agenda and priorities
- Concept note and agenda preparation
- Open virtual consultations

Statement of the UNEP Major Groups & Stakeholders, Africa to the Nineteenth Ordinary Session of the African Ministerial Conference on the Environment Held in Addis Ababa, Ethiopia

We, UNEP Major Groups and Stakeholders, Africa, having met in a hybrid manner in Addis Ababa, Ethiopia on the occasion of the Nineteenth Ordinary Session of the African Ministerial Conference on the Environment (AMCEN), hereby adopt the following Statement.

Preamble

We express our deepest appreciation to the Federal Democratic Republic of Ethiopia for graciously hosting the Nineteenth Ordinary Session of the African Ministerial Conference on the Environment (AMCEN) and for their support to the preparations and hosting of the 2023 Regional Consultative Meeting of the UNEP Major Groups & Stakeholders, Africa. We congratulate the Republic of Senegal for running the presidency of the Eighteenth Session of the African Ministerial Conference on the Environment in an open, inclusive, and successful manner that fostered engagement of the UNEP Major Groups & Stakeholders, Africa particularly in the expert segments of the AMCEN; We congratulate the Republic of Egypt for successfully hosting the Twenty-Seventh Conference of Parties of the United Nations Framework Convention on Climate Change in 2022; the Kingdom of Morocco on the occasion of becoming the first African Presidency of a United Nations Environment Assembly; and the Federal Republic of Ethiopia for ascending to the Presidency of the Nineteenth Session of the AMCEN.

We register our most sincere congratulations to Ms. Elizabeth Maruma Mrema on her appointment as the Deputy Executive Director of the UNEP and to Dr. Rose Mwebaza for her appointment as the Director for the UNEP Africa Office and take this opportunity to express our commitment to working closely and collaboratively with them.

- **Established** in 1985
- **Theme:** Seizing opportunities and enhancing collaboration to address environmental challenges in Africa
- **Venue:** Ethiopian Skylight Hotel, Addis Ababa
- **Dates:** 14-18 August 2023

Nineteenth Ordinary Session of the AMCEN (Outcomes)



- The Addis Ababa Declaration
- 5 Decisions:
 - Omnibus decision on seizing opportunities and enhancing collaboration to address environmental challenges in Africa.
 - African participation in the development of an international legally binding instrument on plastic pollution, including in the marine environment.
 - African preparations for the fifth session of the International Conference on Chemicals Management.
 - Engagement of Africa at the 6th session of the United Nations Environment Assembly.
 - Climate Change: The decision welcomed the outcomes of COP27, including decisions that recognize the special needs of the African continent. Agreed on Africa's outline position ahead of COP28.

Titbits

- UNEP MGS is the official engagement mechanism for non-state actors
- Get accredited to the UNEP to become a member of the UNEP MGS
- RCMs are self-organized by the UNEP MGS and often held back-to-back with AMCEN in Africa
- AMCEN is the regional engagement forum for environment ministers in Africa to form common positions for the continent
