

United Nations Environment Assembly (UNEA)

Key mandates and functions [Governing Council decision 27/2 of 2013]



- Sets the global environmental agenda
- Provides overarching policy guidance and defines policy responses to emerging environmental challenges
- Undertakes policy review, dialogue and exchange of experiences
- Sets the strategic guidance on the future direction of UNEP
- Organizes multi-stakeholder dialogue sessions
- Fosters partnerships for achieving environmental goals through resources mobilization

UNEA-6 takes place 26 February – 1 March 2024, Nairobi Preceded by its "Prepcom", OECPR-6, 19-23 February

UNEA-6 Theme:

"Effective, inclusive and sustainable multilateral actions to tackle climate change, biodiversity loss and pollution"

The UNEA-6 theme was defined on 30 January 2023 by the UNEA Bureau, in close collaboration with the CPR Bureau and based on extensive consultations with the Committee of Permanent Representatives (CPR)



UNEA-6 Ministerial Declaration

Consultations are held under the leadership of the UNEA-6 Presidency, who also holds the pen

- A roadmap for the consultation on the UNEA-6 ministerial declaration was shared in April 2023
- A "zero draft" was made available to all delegations and stakeholder in May 2023, with an invitation to provide inputs in writing
- First informal consultations was held in June 2023, next consultation to be held end of September
- A first full draft of ministerial declaration was shared in August, based on the inputs on the zero draft in writing and at the first informal consultation
- Further consultations and calls for inputs in writing will be organized on 26
 September and during the 10th Annual Subcommittee meeting of the CPR
