






DRIVERS OF FACTORY FARMING IN AFRICA

- International agribusiness seeking new markets –
 African populations and economies growing and urbanizing
- Western model of eating globalized, heavily marketed (e.g., meat, dairy, sugar, processed; fast food)
- Development policies, too: sales pitch:
 industrial = efficient; technical cooperation




Ethiopia: KFC to open outlets in Addis Ababa

A DDIS ABABA (HAN) October 31, 2015 - Public Diplomacy and Regional food Security Initiatives News. By Kaleyesus Bekele. The global fast food chain, Kentucky Fried Chicken (KFC), is going to open fast food restaurants in Addis Ababa next year, it was learnt.

A source close to the company told The Reporter that KFC is under preparation to open unspecific number of restaurants in Addis Ababa in 2016. The source said executives of KFC are holding talks to local suppliers in Ethiopia. "They are very serious about Ethiopian market," he said. If everything goes well KFC will be the first global food chain to enter the Ethiopian market.










LIVE CATTLE ETHIOPIA AND KENYA 2007-2017




LIVE SHEEP AND GOATS ETHIOPIA AND KENYA 2007-2017




LIVE CHICKENS IN ETHIOPIA AND KENYA 2007-2017

Live Chickens Kenya and Ethiopia 2007-2017




LIVE PIGS IN ETHIOPIA AND KENYA 2007-2017






ANIMAL PRODUCTS CONSUMED ETHIOPIA 2003-2013

Animal Product Consumption/Capita Ethiopia 2003-2013




ANIMAL PRODUCTS CONSUMED KENYA 2003-2013

BOTTLENECKS TO SUSTAINABILITY

- Policy maker and public awareness is low;
 impacts mostly hidden
- Factory farming systems being marketed and sold with little/no regulation, training
- Incentives (government, development cooperation) are pro factory farming or neutral
- Not yet a mainstream issue for climate, biodiversity or forest protection advocates or even most groups working on animal welfare

BOTTLENECKS TO SUSTAINABILITY

- Narrative of the "necessity" of large-scale animal agriculture hasn't been contested
- Even small scale farmers (as shown in Kenya photos) are participating
- Corporate power is strong; policy lagging in most countries

OPPORTUNITIES FOR POSITIVE CHANGE

- □ It's getting much harder to ignore:
 - □ The science and impacts for all species, as in UN1.5C, biodiversity and land reports...plus SDGs
 - Food security and public health consequences
 - □ Ugly reality of factory farming when seen
 - Climate change will require (and cause) massive changes

- Public discourse shifting globally: generational change with fewer boundaries in analysis and advocacy
- More awareness across issues, e.g., of forest and species loss from animal ag.; e.g., Amazon fires

AGENDA FOR ACTION

- Engage with policy-makers:
 demystify, illuminate, recommend
- □ Give more attention to corporate accountability
- □ Build alliances across issues: climate & food systems
- □ Reclaim food cultures, respect for non-human world

AGENDA FOR ACTION

- □ Challenge the narrative of "inevitability"
- Support alternative systems but small scale doesn't necessarily mean higher animal welfare
- Huge need: few if any comprehensive efforts now underway to challenge factory farming in Africa
