
- comparative analysis of the animal welfare status of the donkeys at the slaughterhouses versus working donkeys

ANIMAL WELFARE ASSESSMENT

GUIDE

- 548 donkeys at the 4 donkey slaughterhouses and 1,929 working donkeys in 32 counties
- assessment criteria: behavior/human-donkey interactions, general external body condition, injuries, wounds and lameness or any other signs of poor health/diseases
- Scoring was done based on following empathy variables

1=NOT WORRIED **2=SLIGHTLY WORRIED** **3=WORRIED**
4=VERY WORRIED **5=TERRIBLY WORRIED**

KEY FINDINGS ON ANIMAL WELFARE

- 21% of the sampled working donkeys were in poor welfare scores (3 to 5) in comparison to the slaughterhouses where 35% were found to be in poor welfare
- Body condition score was of great concern at slaughter houses
- Harness related sores and lameness due to poor hoof care and injuries was of great concern
- Handling and human-donkey interactions were worst at the slaughterhouses despite the fact that it's a controlled environment.
- This clearly shows the assumptions that working donkeys welfare is worse and they are better off been slaughtered is erroneous.

LEGAL AND POLICY ANALYSIS The Constitution of Kenya 2010

- clean and healthy environment
- protection of consumers health, safety and economic rights
- responsible utilization of natural resources, conservation of biodiversity and control of exploitation
- exploitation of any natural resource at the magnitude of the donkey meat and skin trade demands that there should have been a parliamentary approval before the trade was allowed to go on.
- Protection of Animals
- This is not been met by the donkey slaughter houses



LEGAL AND POLICY ANALYSIS: refers to among others the

Codex Alimentarius, the Meat Control Act, Cap 356 and the Public Health Act Cap 242

- Lack of inspection code
- Lack of official carcass identification number
- Lack of clear guide on how skin has to be identified
- Lack of public environmental audit
- National policy talk of responsibility of government in terms of production food security and genetic preservation which are not met
- International agreements like GLOBAL PLAN OF ACTION FOR ANIMAL GENETIC RESOURCES and the INTERLAKEN DECLARATION-FAO of 2007 talk of genetic conservation which is not been done

COMPARATIVE ANALYSIS

DONKEY SLAUGHTER HOUSES

- 600,000 DONKEY SKINS EXPORTED BETWEEN 2016 AND 2018
- 400 TONS OF MEAT EXPORTED BETWEEN 2016 AND 2018
- 10 TONS OF GELATIN HARVESTED BUT NOT YET EXPORTED
- 245,642 DONKEYS SLAUGHTERED BETWEEN 2016 AND 2018
- TOTAL REVENUE DECLARED IS 1.5 BILLION KENYA SHILLINGS PER YEAR
- 625 EMPLOYEES EARNING AN AVERAGE OF 6,000 TO 20,000 KSHS PER MONTH
- DIRECT TAXES FROM SALES AND EXPORT
- A DONKEY EARNS INCOME ONLY ONCE IN ITS LIFE TIME
- EXPLOITATION HAS NEGATIVE IMPACT ON NATURAL RESOURCES AND LIVELIHOOD OF OTHER PLAYERS IN THE INDUSTRY

WORKING DONKEYS

- 1,929 WORKING DONKEYS ASSESSED IN 32 COUNTIES
- DONKEYS EARN OR SAVES A FAMILY AN AVERAGE OF 600 KSHS PER DAY AND MOST USED FOR 5 DAYS IN A WEEK
- TOTAL ANNUAL INCOME FROM 1,929 DONKEYS IS KSH. 94,353,000.00
- TOTAL 502 PEOPLE EARN ALIVING FROM THE 1,929 DONKEYS DIRECTLY
- MOSTLY INDIRECT TAXES FROM COMMODITIES AND SERVICES ACQUIRED BY THE INCOME
- A DONKEY CAN REPEATEDLY EARN A LIVING FOR THE OWNER FOR UPTO 7-20 YEARS
- NO THREAT TO NATURAL RESOURCES OR NEGATIVE IMPACT TO OTHER PLAYERS IN THE INDUSTRY

CONCLUSION & RECOMMENDATIONS

- WORKING DONKEYS EARN MORE REVENUE, SUPPORT MORE LIVELIHOOD AND ARE IN LINE WITH SDGs WHICH SUPPORT YOUTH AND GENDER EMPOWERMENT COMPARED TO DONKEY SLAUGHTER
- TRADE IN DONKEY MEAT HAS NO IMPACT ON FOOD SECURITY IN KENYA THUS NOT ADDING VALUE
- TRADE IN DONKEYS SKIN THREATENS DONKEY POPULATION AND LIVELIHOOD AND YET DOESN'T EARN THE COUNTRY ANY REVENUE THAT IS COMMENSURATE TO THE EXPLOITATION ITS CAUSING
- THERE IS NEED TO RELOOK AND EVEN BAN THIS DONKEY SLAUGHTER TRADE AND ALSO ACKNOWLEDGE THAT WORKING DONKEYS ARE A KEY PILLAR IN SUPPORTING THE SOCIO-ECONOMIC NEEDS OF THE PEOPLE
