- Communication and advocacy common goal: benefits for people, animal and planet – an inextricable nexus between P,A&P
- Monitoring and evaluation continual improvement
- Resource mobilization justification One Planet, One People, One Welfare The AU-IBAR has developed the Action Plan to implement the APAW's mandate to coordinate the implementation of AWSA, but the Action Plan is not fully implemented due to lack of resources

Functions of the APAW through CCAWA

APAW's Mandate: - "supporting, coordinating and guiding the implementation of the Animal welfare strategy for Africa"

Functions:

- To champion animal welfare and support voices on animal welfare agenda in Africa – AAWC, PADCo, UNEA Process, Vision 2030 for Rabies eradication
- To support initiatives and programs at continental, regional and national levels to strengthen AW through sustainable and efficient involvement of the **public sector** (continental, regional, national), **civil societies** (NGOs, producers' organizations, AWOs), **research & training institutions**; and **private sector** (owners, input providers, equipment suppliers)
 - Established RAWS in IGAD & ECOWAS; ongoing ECCAS
 - RAWNs will be established in IGAD [November 29-30]
 - A Resolution to establish the RAWN in ECOWAS was endorsed in Sep 2022







Key Ongoing Events –with an impact on AWSA

- Process to the Next stage of the Resolution on the Nexus between Animal Welfare, the Environment & Sustainable Development
 - CCAWA, through APAW, has the agency to advance the interests of AU-MS [APAW has the 54 MS, RECs and AU-IBAR as members]
