previous stock-taking Assessment Findings

Key Barriers

Governance challenges, financial constraints, limited political commitment, capacity-building gaps

Funding Issues

AWSA implementation remains underfunded with fragmented donor funding and limited private sector engagement

Regional Progress

South and East Africa show progress while West and Central Africa show gaps in progress

Although Southern and East Africa show improvements in productivity, income, and food security, gaps in data collection limit comprehensive impact analysis.


Recommendations and Next Steps

Update AWSA results framework and develop targeted strategies for lagging regions



Integration into National National Strategies

Mainstream AWSA into national and developmental frameworks

Training programs for stakeholders, especially CAWFPs as trainers and data managers

1.Donkey Species Preservation In Africa

On 18 February 2024, African Heads of States and governments at the 37th African Union Summit made an Executive Decision on Donkey Preservation and moratorium on mass slaughter for hide export.

Socio-Economic & Welfare Concerns

Recognized critical role of donkeys in livelihoods and lack of data for evidence-based policies

Population Decline & Reproductive Reproductive Challenges

Raised alarm over rapid decline due to international skin trade

Call for African Common Position

Urged AU Commission to lead unified response to mitigate donkey exploitation

4

Development of Pan-African Strategy

Requested continent-wide strategy with support from AU, RECs, WOAH, FAO

Long-Term Vision

Population Recovery

Restore and stabilize donkey numbers across African continent through targeted interventions.

Rural Development

Strengthen rural economies through preserved donkey resources and enhanced productivity.

Implement responsible practices for donkey utilization balancing conservation with community needs.
